Chambers of Commerce Trip to Washington, D.C.



CNTA was represented by Mal McKibben on a 2-day trip to Washington, D.C., along with nearly 50 community leaders from around the CSRA. This is an annual event arranged by the Chambers of Commerce of Augusta, North Augusta and Aiken, representing five CSRA counties.

Meetings were held with our representatives, senators, DOE senior managers, the Corps of Engineers and the Secretary of the Army. Presentations were made to each of them about current concerns and issues. For SRS the presentation included several needs:

- Ensure adequate funding to support plutonium disposition missions, stabilization of other legacy nuclear materials and off-site spent fuel and waste.
- Stockpile stewardship, including future pit manufacturing capability.
- Environmental initiatives, including site cleanup disposition path for high-level waste.
- At site visitor's center
- An accelerator to produce medial radioisotopes, serve as a backup for tritium production, and do international research on neutronics and radiation effects.

We also told them of our 50th Anniversary celebration.

With David Michaels, DOE Under-Secretary of Energy for Environment and Health, we questioned the approach that would be used to select persons to be compensated for radiation injury.

Issues


CNTA has been involved in several key issues over the past year. Three of these are mentioned briefly below.

Plutonium Disposition

CNTA was a very active participant leading up to the selection of SRS as the site for all three projects for disposition of surplus weapons plutonium—Pit Disassembly and Conversion, Plutonium Immobilization and Mixed Oxide (MOX) Fuel Fabrication. Since that selection, we have continued to be active in assuring the public and public officials of their expected safety of operations. We have also provided testimony at DOE and NRC hearings.

Yucca Mountain

CNTA and the Savannah River Section of the American Nuclear Society gave joint testimony at a public hearing in Atlanta on the viability of Yucca Mountain for disposal/storage of high-level wastes and spent nuclear fuel.



DOE Initiative to Compensate Injured Workers

DOE recently announced an initiative to financially compensate workers or their surviving families who had been physically injured or killed because of excessive on-the-job exposure to excessive radiation doses or hazardous chemicals.

CNTA fully supports compensating injured workers, but we expressed concern to DOE and our legislators that the wording of the DOE announcement suggested that they may be planning to compensate workers who receive radiation doses within DOE guidelines. We feel strongly that this would not be technically justified and would create a very bad precedent. This issue is not settled. The Senate passed the bill (but strangely excluded injuries from chemical exposures), but the House has not passed it.

CNTA Speakers' Bureau

We are re-starting a Speakers Bureau to present talks on a variety of subjects to public groups. Tom Parkinson is chairing the committee to make this happen. Other members of this committee are: Mike Hosang, USC-Aiken; Mel Buckner, SRTC; Ben Cross, SRS Planning; and Mal McKibben. It is our intention to present these talks at schools, civic groups, church groups, technical societies, environmental groups, etc.

In the first meeting of this committee a preliminary list of talks were agreed on as follows:

- Economic Impact of SRS on the CSRA
- The Real Risks of Transporting Nuclear Materials
- Long-Range Options for Managing Spent Nuclear Fuel and Wastes
- Why Dispose of Surplus Plutonium with Mixed Oxide (MOX) Fuel?
- Use of Radioisotopes in Nuclear Medicine

- The History and Future of SRS
- The Case for Nuclear Power
- Plans for Environmental Cleanup at SRS
- Putting Radiation Risks in Perspective
- What's Happening with Food Irradiation?

We are planning a vigorous promotion effort to identify and contact candidate organizations and we will create new, attractive brochures. If you would like to volunteer to speak, or have ideas for making the program more effective, please give us a call.

Center for International Trade and Security

CNTA sponsored a meeting July 24th with the Center for International Trade and Security (CITS), a non-proliferation “think tank” at the University of Georgia in Athens. Our group included Mal McKibben, Mel Buckner (Savannah River Technology Center), Jerry O’Leary (SRS Safeguards and Security Technology), Dave Ziggleman (SRS Nuclear Cities Initiative), Ratib Karam [Director, Education, Research and Development Association (ERDA) (Georgia)], and Joe Spencer [Director, South Carolina Universities Research and Education Foundation (SCUREF)].

Gary Bertsch, Director of CITS, led the eleven member CITS group, which included staff members and several graduate students.

The purpose of the meeting was to get acquainted with the activities of each group and to explore the possibilities of future collaborations.



Two broad areas of potential collaboration were identified, with several specific projects in each broad area. These areas were: (1) national and international education programs on nuclear energy, export control, and control of proliferation of weapons of mass destruction; (2) technical support of US Government-related projects in the former Soviet Union. A new initiative created by former Senator Sam Nunn and funded by Ted Turner will likely involve CITS and will function in both of the broad areas above.

Forming A National Alliance

CNTA is the largest grass-roots organization in the U.S. that supports beneficial applications of nuclear technologies. Similar, but much smaller groups exist at nearly all DOE sites. We are now urging these pro-nuclear groups to broaden their scope, and to join us in creating a national alliance of such groups.

The anti-nuclear groups have magnified their voices by forming alliances. We can, too!

Mal McKibben has met with two of these groups—“Coalition 21” in Idaho Falls and “Center for Reactor Information” in Argonne, Illinois. The Board of Directors of the American Nuclear Society and the Eagle Alliance have offered their support for this effort.

We are planning a meeting in early 2001 to create a national alliance.

Richard Rhodes: An Environmentalist Supports Nuclear Power



Richard Rhodes was our Teller Lecturer in 1998. He won a Pulitzer Prize for “The Making of the Atomic Bomb”, and he also wrote “Dark Sun”, documenting the making of the hydrogen bomb.

Mr. Rhodes is a strong “environmentalist” who has become a very effective advocate for nuclear power, food irradiation and nuclear medicine. He coauthored an article, “The Need for Nuclear Power”, in the January/February issue of *Foreign Affairs*. It is one of the most persuasive articles we have seen on the need for nuclear power. "I DON'T LIVE THERE ANYMORE" TO OPEN STATE TOUR AT USCA ETHERREDGE CENTER DURING THE 50TH ANNIVERSARY OF SRS

The acclaimed musical "I Don't Live There Anymore", by Lawrence Holofcener and Gerard Kenny, opens Friday, September 8 at 7:30 p.m. at the University of South Carolina Aiken's Etherredge Center. Performances will also be held Saturday, September 9 at 7:30 p.m. and Sunday, September 10 at 2:30 p.m. Tickets, \$18 for Adults and \$5 for students, are available from the Etherredge Center Box Office, (803) 641-3305. Group discounts (15 or more) are \$15 per person.

The "I Don't Live There Anymore" productions are a featured event of the 50th Anniversary of the Savannah River Site. Following the Etherredge Center opening, the musical will tour throughout South Carolina: York's McCelvey Center, September 15-16 at 7:30 p.m.; Charleston's Sottile Theatre, September 22 at 7:30 p.m.; Beaufort's USCB Performing Arts Center, September 23 at 8:00 p.m.; Pendleton Playhouse on September 30 at 7:30 p.m.; and the Sumter Opera House, October 7,13-14, 20-21 at 7:30 p.m. and October 8 at 2:30 p.m.

Premiered during Charleston's 1993 Spoleto Festival, 'I Don't Live There Anymore' was called the "runaway hit of the Festival" and played to standing ovations. The musical is based upon an incident in American history so insignificant as to pass unnoticed by historians. And yet it conceivably altered the course of our history, even that of the world, in helping to prevent World War III, when the Government selected 300 square miles in SC to build the H-bomb and in the process destroyed 3 communities, including an 80 year-old town. But "I Don't Live There Anymore" is not about bombs or the eradication of a town: it's about love...young love requited, old love

uncovered and the sacrificial love of people for people.

SRS Celebrates 50 Years of Excellence

In 1998 CNTA organized the community-based 50th Anniversary Committee and invited John Granaghan to be its Chairman. Through the successful efforts of this Committee, many events are being held throughout 2000 to commemorate this historic event. The kickoff was in February with a press conference held at the Aiken County Museum which featured a traveling exhibit of memorabilia from the early construction of SRS. These included copies of official letters, local newspaper articles, pictures, and artifacts from the construction days.

The press conference was followed by the presentation of the SRS Trophy at the Aiken Trials in March. Jim Gaver was kind enough to allow SRS to present what is usually known as the Gaver Trophy at this event.

An essay contest was conducted in the local middle schools. The winners were: Chris Allen, 7th Grade, Wardlaw Academy (1st Place); Sarah Stone, 6th Grade, Wardlaw Academy (2nd Place); and Amy Rhoden, 8th Grade, Westminster Preparatory (3rd Place).

The highlight of the spring events was the Technical Symposium celebrating 50 years of excellence in science and engineering held on May 17th at the Etheredge Center, USC-Aiken. The Technical Symposium Committee was chaired by Bill Reinig, Fred Springer handled the editing and publishing of the papers, and Kent Rosenberger and Steve Epperson were in charge of logistics and providing the hard work behind the scenes.
