A WORD OR TWO FROM OUR NEW EXECUTIVE DIRECTOR

Hello everyone. My name is Clinton Wolfe. I have recently been named to the position of Executive Director of the Citizens for Nuclear Technology Awareness (CNTA). I have been associated with the nuclear industry for nearly 40 years in positions ranging from research chemist at the Westinghouse Electric Corporation's R&D Center, manager of chemistry and corrosion technology organizations with Westinghouse Nuclear Steam Generator Divisions to the Savannah River Site, where most recently I was manager of the Strategic Materials Technology Department in the Savannah River National Laboratory. I retired from the Laboratory in 2005.

I have thoroughly enjoyed my retirement, but man does not live by golf alone (you may want to remember that for future attribution). There are very few endeavors that I would consider pursuing that would take me away from my thoroughly enjoyable pastime. However, I am thoroughly convinced that our country and our planet require an urgent solution to the anthropogenic causes of global warming. Many will argue, and Congress will appropriate money for greater use of renewable energy sources. Such initiatives are laudable and deserve attention; however, although these approaches can be helpful in niche markets, they cannot make a significant impact on the wholesale generation of electric power. Someday, we've been saying for the past 50 years, we will harness fusion power for the generation of electricity. That opportunity has habitually been 50 years in the future.

The only major replacement energy source on a scale comparable to the fossil fuel in use for electric power would be the generation of electrical power in nuclear power plants. It is something to celebrate that we do have an answer, but for many years the answer to this problem has been delayed and stymied in large measure by the economics of bringing new plants on line in the face of long delays in licensing and permitting. A lack of understanding about the science and the

truth concerning the safety of such systems contributed to the opposition to new start ups. It isn't helpful to find blame or to criticize those we believe to be speaking untruths, but it is helpful to continue the education of the public so that they can come to the same conclusions that many of us have come to who have been intimately familiar with the technology for a number of years. With public support, standardized designs, streamlined licensing and permitting, the economics of nuclear power generation can be very favorable. There are no significant technical issues to a heavier reliance on nuclear energy. There certainly are political issues, some of which derive from a lack of understanding by the general public about things nuclear. This is where we have a very important role to play and we should do so enthusiastically and proactively while continuing to rebut those who are speaking the dogma of some of the more avid antinuclear organizations.

Both my wife Ginny and I have been associated with the nuclear industry for a long time. We live here in Aiken, and we would like to see the Nuclear Renaissance realized, just as we watched the decline of the industry some 25 to 30 years ago. Better yet, we would like to be a part of that Nuclear Renaissance and make some contribution to the education of those people whose support is required for this Renaissance to occur. I am honored to have been selected to follow in the footsteps of Mal McKibben, our Director Emeritus, and I look forward to working with you to achieve our goals and objectives including making the best use possible of the tremendous investment at the Savannah River Site. That investment by the American taxpayer should not be squandered but, rather built upon to achieve the nuclear vision of the future.


